- To protect and defend our rights and property
- In connection with a business transfer, such as a merger or acquisition

4. Security of Information

We take reasonable measures to protect your information from unauthorized access, use, and disclosure. However, no method of transmission over the internet or electronic storage is completely secure.

5. Your Choices

You can opt out of receiving marketing and promotional communications from us by following the instructions provided in our communications. Even if you opt out, we may still send you non-marketing communications, such as those about your account or our ongoing business relations.
